





# **Fraser River Tunnel Project**

## DAILY NAVIGATION NOTIFICATION

#### **November 09, 2025**

This Daily Notification provides an update on the status of geotechnical investigation works for the Fraser River Tunnel Project. These daily updates are a supplement to the weekly NAVWARN which should be referred to for further details of the project.

Today's activities include infilling the test area with clean river sand. The work area is in the main river channel north administrative safety zone. Near the Canfisco property (13140 Rice Mill Road).

Refer to the figures, coordinates, and further details presented below.

Works will occur between **0700 hrs and 1900 hrs.** The McKenzie Barge will remain positioned onsite with the Catherwood tug outside of the working hours.

#### **Summary of Activities:**




Figure 1: Site Clearance (Dredging)

FRPD McKenzie Derrick/Spud Barge – **Vessel MMSI (AIS) - 316058902** and Tugboat SEA IMP IX (Catherwood) – **Vessel MMSI (AIS) - 316014646** will be sited at the work area. See Figure 1.

- The work area is defined as:
  - o 49° 7'28.19"N / 123° 4'29.81"W
  - o 49° 7'26.71"N / 123° 4'28.01"W
  - o 49° 7'23.52"N / 123° 4'33.05"W
  - o 49° 7'25.68"N / 123° 4'35.65"W

#### VHF channels to be monitored include:

Channel 16 for the Canadian Coast Guard – Emergency, Channel 74 for the Canadian Coast Guard. Channel 69 for the marine contractor (FRPD).

### **Daily Activities**

FRPD McKenzie Derrick/Spud Barge will be infilling the test area and be supported by FRPD scow barges, FRPD 12, 21, and 22. Empty scow barges will be transported down river to the Mainland pit on No. 5 road and return loaded to the work area.













#### **Special Requests**

Mariners are advised to avoid the geotechnical staging area, navigating via the main navigation channels.


