DAILY NAVIGATION NOTIFICATION

December 01, 2025

This Daily Notification provides an update on the status of geotechnical investigation works for the Fraser River Tunnel Project. These daily updates are a supplement to the weekly NAVWARN which should be referred to for further details of the project. Figures are for illustrative purposes only and not to be referenced for navigation purposes.

Summary of Activities:

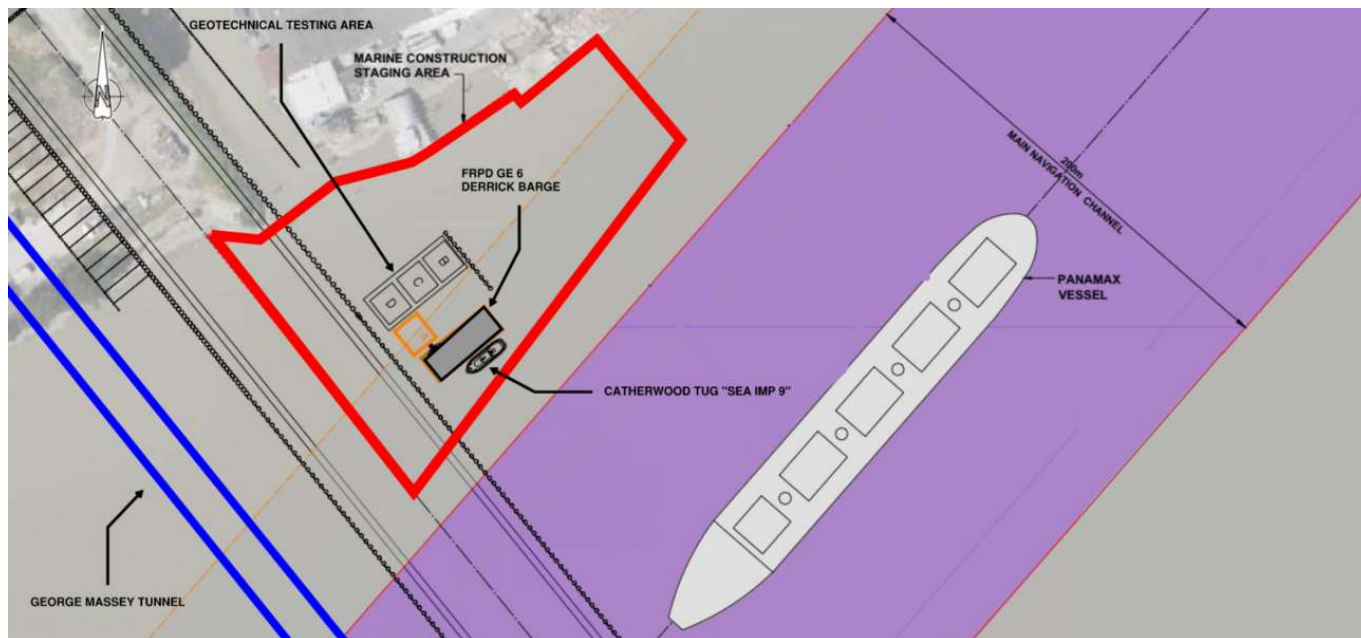


Figure 1: Test Area (In-River Test Section)

In-River Test Section (Figure 1):

Today's activities include ground improvement trials using the FRPD GE6 spudded/Derrick barge – **Vessel MMSI (AIS) - 316058929**. The work area is in the main river channels north administrative safety zone. Near the Canfisco property (13140 Rice Mill Road).

Works will occur between **0700 hrs and 1900 hrs**.

Tugboat Seymour Crown – **Vessel MMSI (AIS) – 316016663** will be available during working hours only to assist transiting vessels – upon request from the Pilots.

Supplemental Test Dredge (Figure 3-5):

Bathymetric Surveys will be conducted in the Test Dredge area from the FRPD survey boat 'Salish Surveyor' – **Vessel MMSI (AIS) - 316044605**

Works will occur between **0700 hrs and 1900 hrs**.

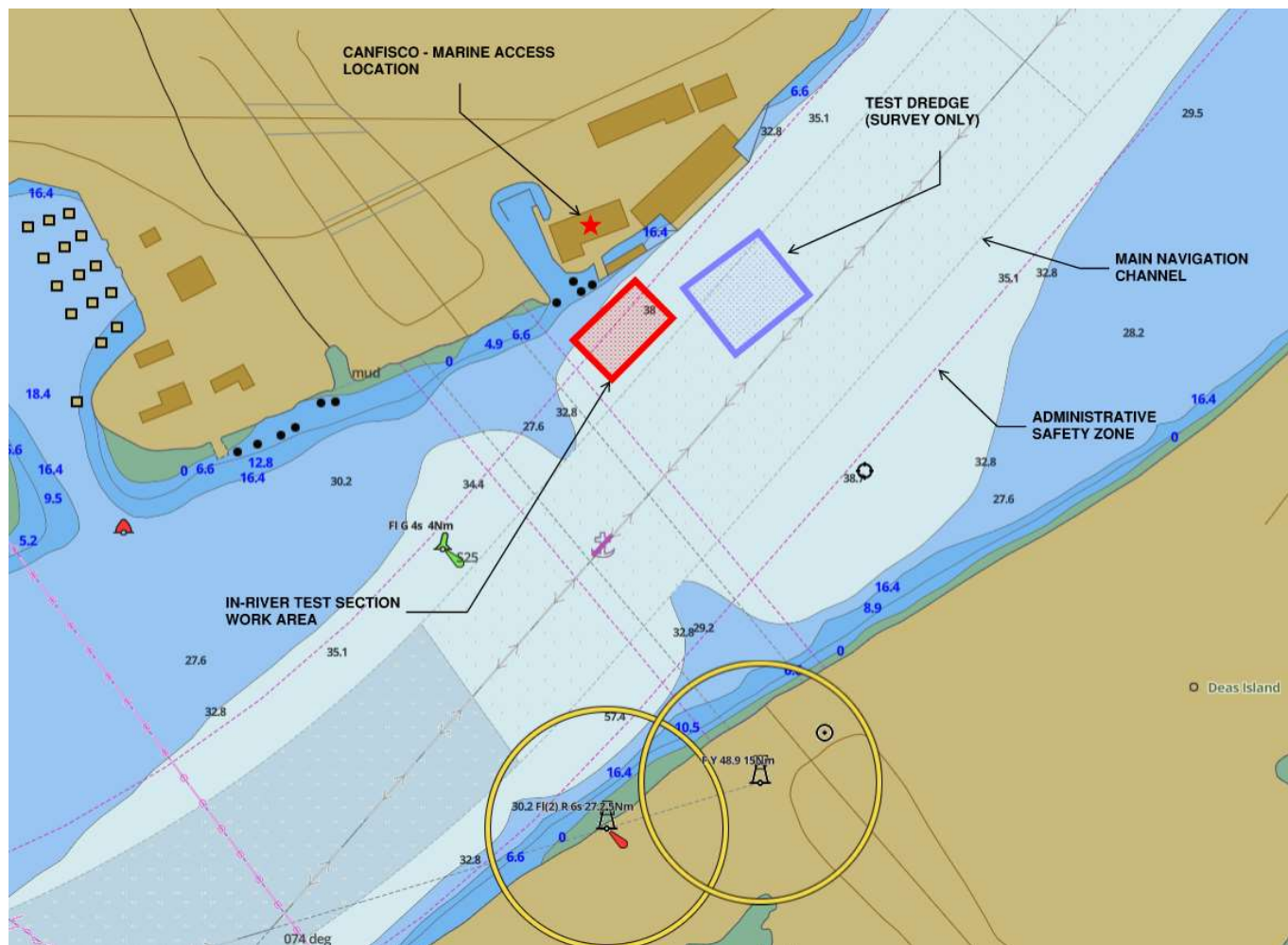


Figure 2: Test Areas (Marine Chart)
